The parking lot entrance for visitors to One Bergen County Plaza is located between One Bergen County Plaza and the Justice Center, off Hudson Street. The guard at the security booth will direct you to the proper area. You will be issued a pass that will direct you where to park. You must park where the guard tells you to park. Assure that your parking pass is clearly visible while parked or a summons may be issued.

*The entrance to the parking for the Justice Center/Court House is located off Court Street and it is a pay lot. If a small yellow ticket is issued to you, you have entered the wrong parking lot. Turn around and exit immediately or you will be charged. Parking for One Bergen County Plaza is free, however you must be in the proper lot.*

Enter One Bergen County Plaza via Hudson Street. The guard at the entrance booth will direct you to a parking location.

**From Route 4 East/West:** Exit at Hackensack Avenue, Business District. Hackensack Avenue becomes River Street. From River Street make a right onto Kansas Street (Costco will be on the left) At the light, turn right onto Hudson and make the first right into the Bergen County Plaza driveway.

**From Route 17 North:** Exit at Polifly Road. Four lights later make a right onto Essex Street. After you cross the railroad tracks continue until you see the courthouse ahead. The road curves and splits. Bear right onto Hudson Street and make your first left into the Bergen County Plaza driveway.

**From Route 17 South:** Exit at Essex Street (Maywood/Paterson). Make a left at the stop sign onto Essex Street. Stay on Essex Street past the Hackensack University Medical Center and over the railroad tracks. Follow directions from above.

**From Route 80 East & West:** Exit at #66. Go to the light. Make a left onto Hudson Street. As Hudson Street starts to curve you will see the courthouse ahead; One Bergen County Plaza will be on your right. Just after the building make a right turn into the driveway.

- Enter the building by the main entrance and let the security officers know you are attending an Office for Children Workshop.
- Your workshop is on the 3<sup>rd</sup> floor. As you exit the elevator go down the center hall and the workshop room will have a sign outside the door.
