**HISTORIC PRESERVATION COMMISSIONS and the MUNICIPAL LAND USE LAW:** [The following are excerpts from the *New Jersey State Historic Preservation Office (SHPO) and Office of State Planning (OSP)* jointly prepared publication, April, 1996, on Historic Preservation and the Municipal Land Use Law.]

Municipalities in New Jersey obtain their authority to identify, evaluate, designate and regulate historic resources (individual sites and districts) from the *Municipal Land Use Law (MLUL)*, the enabling legislation for municipal land use and development planning, zoning, and, since 1986, historic preservation zoning (N.J.S.A. 40:55D-1 through 136). When amendments to the MLUL went into effect, municipalities were able to 1) incorporate historic preservation plan elements into their Master Plans; 2) adopt a Historic Preservation Ordinance; 3) create a Historic Preservation Commission.

The most effective protection of historic resources is designation and regulation at the municipal level. Historic preservation designation at the municipal level is a separate action that is not connected to listing in either the *New Jersey or National Register of Historic Places [SR/NR]* (see below). Listing alone on the SR/NR does not bar a private property owner from altering or even demolishing a listed property.

Communities may adopt a zoning ordinance that designates and regulates historic sites or historic districts and establishes design criteria and guidelines. Historic preservation designation is described as an “overlay” to zoning because, as Section 65.1 of the MLUL states, historic designation is “in addition to such designation and regulation as the zoning ordinance may otherwise require.”

Historic preservation ordinances vary among municipalities in the degree of authority granted to Commissions to protect designated historic properties. The strongest ordinances allow the Historic Preservation Commission to review proposed alterations, new construction, and demolitions affecting designated historic properties and to make binding decisions regarding the issuance or denial of municipal permits. An alternative approach to permit review grants the planning or zoning board the decision-making authority after the Historic Preservation Commission has issued a recommendation.

*Design Guidelines:* As with criteria for evaluating historic significance and integrity, design guidelines provide an objective, uniform and consistent foundation for making decisions on alterations, new construction or demolition affecting historic properties. State Plan policies recommend that municipalities incorporate into their planning and development review activities design guidelines that protect the character of historic sites, landscapes and structures; promote adaptive re-use; and enable development and redevelopment that maintain, complement and enhance scenic and cultural values.

Design Guidelines are formulated on the basis of the historic and architectural character of the designated historic properties. The goal of the design guidelines is to ensure the appropriate treatment or sensitive alteration of historic properties, the maintenance and retention of historically and architecturally significant details, and the visual compatibility of new construction in historic districts. Design guidelines are the legally adopted standards used to guide the decisions of historic preservation commissions and to help residents and property owners protect and enhance designated historic properties and districts.

**THE NEW JERSEY AND NATIONAL REGISTERS OF HISTORIC PLACES (SR/NR)** [The following are excerpts from the *New Jersey State Historic Preservation Office (SHPO)* publication on the New Jersey and National Registers.]

The National Register of Historic Places (NR) is the official list of the nation's historic resources worthy of preservation. Congress established the first historical registry in 1935 through the passing of the Historic Sites Act. This act directed the Secretary of the Interior to designate properties of national importance as National Historic Landmarks. The 1966 National Historic Preservation Act (80 Stat. 915, as amended) established a National Register of Historic Places to include significant districts, sites, structures, buildings, and objects of local, state and national interest. The 1966 act instructed the governor of each state to appoint a State Historic Preservation Officer (SHPO) to work in partnership with the US Department of the Interior's National Register Office. For NJ, the SHPO is the Commissioner of the Department of Environmental Protection. The Historic Preservation Office constitutes the professional staff at SHPO.

The New Jersey Register of Historic Places (SR) is the official list of NJ's historic resources of local, state, and national interest. Created by the New Jersey Register of Historic Places Act of 1970 (N.J.S.A. 13:1B-15.128 et seq.), the NJ Register is closely modeled after the National Register Program.

The SR/NR provide a degree of review and protection from public encroachment. Section 106 of the National Historic Preservation Act of 1966, as amended, provides for review of any federally licensed, financed or assisted undertaking for properties listed on, or eligible for listing on, the National Register. The New Jersey Register law requires review of any state, county or municipal undertaking involving properties listed on the New Jersey Register. These reviews are designed to prevent destruction or damage of historic resources by public agencies.

Inclusion on the NR enables the owner of a property to take advantage of several financial benefits. The Tax Reform Act of 1986 permits owners and some lessees of historic buildings to take a 20% income tax credit on the cost of rehabilitating such buildings for industrial, commercial or rental residential purposes. The rehabilitated building must be a certified historic structure that is subject to depreciation, and the rehabilitation must be certified as meeting standards established by the National Park Service. Furthermore, Historic Preservation Bond Fund matching grants and low interest loans for rehabilitation and restoration are available to state, county and municipal agencies and non-profit organizations with properties listed on the SR.

Listing on the SR/NR does not place restrictions on private property owner rights. Within the limits of local municipal zoning laws, private property owners can do anything they wish with their property, provided no federal or state license, permit, or funding is involved. If a private property owner objects to National Register listing by a notarized letter to the SHPO, the nomination is sent to the National Register Office for Determination of Eligibility, but the property is not listed on the National Register. A Determination of Eligibility provides for re-

view of federally sponsored encroachments as detailed previously, but tax benefits will not apply unless the property is actually listed on the National Register.
