RESIDENT GOLF REGISTRATION & RENEWAL FORM

Registration is valid for length of golf season only (March – December)

MAIL-IN RENEWALS: Mail the following items to the above address:

- Completed form
- Last year's **original** golf ID card*
- Copy of your driver's license**
- Stamped self-addressed envelope
- Check payment

Make your check payable to the Bergen County Department of Parks. *If you have lost your golf card, you must renew in person and there is an additional \$10 fee.

IN-PERSON NEW REGISTRATIONS & RENEWALS: Bring the following items to any golf course or to the golf office:

- Completed form
- Driver's License with photo**
- Last year's golf ID card *(Renewals only)
- Cash or credit card payment (Visa or MC)

**Juniors need birth certificate & school, library or report card & have resident parent show driver's license. *There will be an additional \$10 replacement fee for a lost golf card.
