OPEN SPACE TRUST FUND COUNTY PROGRAM
2010 PROPOSED REVISED ALLOCATIONS

Please Take Notice: As required by the State of New Jersey in N.J.S.A. 40:12-15, et seq., the Bergen County Trust Fund Public Advisory Committee, on behalf of the Bergen County Board of Chosen Freeholders, will conduct a public hearing on the proposed revised allocations of its Open Space Trust Fund's County Program for Funding Year 2010, on **Monday, January 30, 2012, at 6:00 p.m.**, in the Freeholder Public Meeting Room, 5th Floor, at One Bergen County Plaza, Hackensack, New Jersey, at which time public comment will be taken.

In accordance with N.J.S.A. 40:12-15.3(d), the County of Bergen is proposing funding allocations from the Bergen County Open Space, Recreation, Farmland & Historic Preservation Trust Fund for the Trust Fund's 2010 County Program totaling \$6,131,790.00 for the following projects:

Open Space Acquisition Projects Totaling \$4,775,303.00 as follows:

- Borough of Haworth - \$360,000.00 for White Beeches Golf Club Development Rights
- Borough of Ramsey - \$450,000.00 for Rockland Electric Trail
- Township of River Vale - \$1,225,000.00 for River Vale Country Club
- Borough of Saddle River - \$1,365,303.00 for Marker Property
- Township of Wyckoff - \$1,375,000.00 for Maple Lake Property

Recreation Development Projects Totaling \$700,000.00 as follows:

- Bergen County Department of Parks - \$700,000.00 for Hackensack River Pathway

Historic Preservation Projects Totaling \$656,487.00 as follows:

- County of Bergen - \$0.00 for Waterworks Plant Phase 2
- Concerned Citizens of Allendale - \$30,000.00 for Fell House Preservation Plan
- Meadowlands Museum - \$72,625.00 for Yereance-Berry House Roof Repairs
- Ridgewood Board of Education - \$230,000.00 for Beech St. School Slate Roof Replacement
- Borough of Upper Saddle River - \$7,500.00 for Hopper-Goeschius House Exterior Restoration
- Waldwick Community Alliance - \$293,862.00 for Waldwick Train Station Exterior Restoration
- Borough of Wood-Ridge - \$22,500.00 for Brinkerhoff House Preservation Plan

The anticipated commencement date for these proposed projects is on or about March 21, 2012. The anticipated completion date for these proposed projects is by or about August 21, 2013.

The above proposed revised funding recommendations replace the funding recommendations previously presented by the County for public hearing on August 24, 2010.
