	Mr. Raguseo then introduced Bond Counsel John Draikiwicz of Gibbons Law who gave an overview of the transaction and the need for this Special Meeting in order to comply with the estoppel period for the adoption of this bonds and notes issue. His overview included a detailed explanation of the long term debt as well as the working capital contained in the bonds and notes issue.	

Commissioner Randall asked for a more detailed overview of the bonds and notes issue. Mr. Draikiwicz explained the breakdown of the issue. He also mentioned that the BCIA may in the future, two to three years from now, require an additional financing in connection with BNBMC.
