SAMPLE BALLOTS ARE MAILED TO EVERY REGISTERED VOTER THE WEEK PRIOR TO THE ELECTION LISTING THE OFFICES, CANDIDATES AND THE QUESTIONS TO BE VOTED UPON ALONG WITH YOUR ELECTION VOTING DISTRICTS NUMBER AND POLLING LOCATION.
