

BERGEN COUNTY COMMUNITY DEVELOPMENT FY 2020 – 2024 CONSOLIDATED PLAN and FY2020 ACTION PLAN PUBLIC HEARINGS FOR REGIONAL COMMITTEES

The County of Bergen Community Development is in the process of developing its FY2020 - 2024 Consolidated Plan and Annual Action Plan for FY2020. The Consolidated Plan serves as the County's application for federal funds from the U.S. Department of Housing and Urban Development (HUD) for the following programs: Community Development Block Grant (CDBG), HOME Investment Partnership (HOME) and Emergency Solutions Grant (ESG). As part of the plan, Bergen County Division of Community Development must identify the County's housing, community and economic development needs. Then develop goals and objectives to address those needs.

Community Development is requesting your assistance to help identify the housing, community and economic development needs for Bergen County. Your responses will help us identify how the County's funding will be prioritized over the next 5 years. Under the current pandemic public gathering is prohibited and in order to comply with national and local social gathering requirements testimonies will be heard via teleconferencing. In order to obtain your input, Community Development has scheduled regional public hearings via telephone to obtain public input on these needs throughout the County.

This forum will allow anyone desiring to make a comment or discuss policy to participate. A court stenographer will be present via telephone to take your comments/testimony which will become a part of the Bergen County's 5 year Consolidated Plan.
