

CHILDREN'S AFTER-SCHOOL TREATMENT SERVICES (C.A.T.S.)

OVERVIEW

- C.A.T.S. is a therapeutic after-school program designed to help improve the social skills of elementary and middle school-aged children.
- The C.A.T.S. program includes playbased group therapy, art therapy, therapeutic recreational activities and family support services.
- Individual therapy is offered to children who would benefit from more intensive therapeutic work.
- C.A.T.S. services are provided at no cost to participating families.
- Referrals are accepted from parents, schools, and other community agencies.



SERVICES

- C.A.T.S. targets social, emotional, and developmental issues which impact each child's development and growth.
- The C.A.T.S. curriculum is based on <u>The</u> <u>Second Step Program</u> which helps children to develop empathy, gain greater impulse control, practice problem solving methods, as well as increase their frustration tolerance through anger management and relaxation training.
- C.A.T.S. also provides a parent group that focuses on parenting strategies and support.
- C.A.T.S. groups are held Tuesdays, Wednesdays, and Thursdays during the academic school year.
- The program follows the Bergen County Special Services school district's holiday, vacation, and school closing schedules.

GETTING STARTED AT C.A.T.S.

- The first step of the treatment process is a phone screening with the parent/ caregiver to determine a child's ability to benefit from the C.A.T.S. program.
- If a child seems appropriate for the C.A.T.S. program, an intake interview is scheduled with the parent/caregiver. During this process, the therapist collects detailed information about the child and the family.
