**“Social Work Ethics”**

**About the Course:**

Social Work Ethics is a five-hour intermediate level workshop geared towards licensed mental health professionals practicing clinical work in a variety of settings. The course will cover the main components of ethical practice, from both an agency and practitioner perspective, as well as from the licensing point of view. Designed to be interactive, examples will be used to tease apart the various issues and explore the strategies that will illustrate how the real world can be a complex and at times, challenge the black and white many would hope for when real human beings are involved.

**About the Instructor:**

Mr. Michael Tozzoli is Chief Executive Officer of West Bergen Mental Healthcare and has oversight/management/responsibility for over 200 staff members and operations of the entire agency. Attendees will participate in small group discussions to apply course material to individual clinical practice. They will identify "real world" examples and apply a standard process to evaluating them. Groups to present issue, articulate the complexities and get feedback from the entire class.
