## "Somatic Healing Practices for Trauma"

#### About the Course:

This workshop will teach social workers how to identify and treat psychophysiological symptoms of trauma and how to utilize somatic healing practices. The workshop will include lecture and experiential practices on somatic healing practices to heal trauma and PTSD. Principles of the trauma resolution model, *Somatic Experiencing (SE)* developed by Dr. Peter Levine will be reviewed including, titration, pendulation and orienting. Participants will learn a variety of skills to negotiate symptoms of trauma that clinicians typically avoid. Clients typically leave sessions with a greater tolerance for difficult bodily sensations and increased vitality.

#### About the Instructor:
