

## UPON RECEIPT OF SFMNP VOUCHERS:

- ❑ Sign each voucher by the "X" on the front of the check.
- ❑ Each voucher is worth \$6.00. You may use one at a time or up to five on any shopping trip.
- ❑ Farmers cannot give change. If your total purchase goes over the amount of the voucher, you can pay the difference with an alternate form of payment (SNAP, cash, credit/debit).
- ❑ Vouchers can only be used to purchase NJ grown fresh vegetables, fruits, and herbs.
- ❑ Items other than vegetables, fruits, and herbs such as cake, bread, pickles, and cheese cannot be purchased with the vouchers.
- ❑ Produce grown in other states such as bananas cannot be purchased with the vouchers.
- ❑ Vouchers must be used by November 30<sup>th</sup>.
- ❑ Many farm stands close by the end of October; call market for specific information.

## ELIGIBILITY CRITERIA

Persons who meet the following criteria are eligible to participate in the Senior Farmers' Market Nutrition Program (SFMNP) and receive free vouchers (total value \$30.00) to purchase the fresh NJ grown produce of your choice.

- ❑ **Age 60 or older**
- ❑ **Bergen County resident**
- ❑ **Maximum gross monthly household income:**
  - 1-person household \$1,986.
  - 2-person household \$2,686.
- ❑ **Complete an application and sign a declaration to attest to meeting eligibility criteria**
- ❑ **Register once a year only**

*Vouchers are limited and available on a first-come, first-served basis.*

SFMNP vouchers may be used at any USDA approved farm stand.

**A list of USDA approved farmers' markets in Bergen County where you can use your vouchers to shop for NJ fresh produce is printed on the inside of this folder.**

Vouchers are not redeemable at grocery stores, farm stores or markets not approved by the USDA.

Look for the WIC/FMNP yellow poster at the farmers market or ask if they accept SFMNP vouchers before shopping.
