The Senior Farmers' Market Nutrition Program (SFMNP) is available to low-income residents of Bergen County who are 60 years of age or older. Applicants must provide proof of age, residency in Bergen County, and income at the time of application. The benefits can be used to purchase fresh, New Jersey-grown produce, including fruits, vegetables, herbs, and honey, at USDA-approved farmers' markets. The benefit amount is \$40.00 per person.

Apply in person on scheduled dates at selected sites across Bergen County.

A list of participating farmers and farmers' markets that accept E-Benefits will be provided.

2025 Qualifying monthly household income must be at or below:

\$2,413 for household of one (1) \$3,261 for household of two (2)

Appointments are required for groups of 5 or more. To schedule an appointment, call 201-336-7462.
