- The Bergen County Zoo will only release campers to adults 18 years of age or older listed below, regardless of their relationship to the child. Please be sure to list all parents, guardians, relatives, or friends that are permitted to pick up your child.
- It is implied that the adults listed on the form may be contacted by the camp while the camper is in the care of camp, and may be contacted if the camper needs to be picked-up during the course of the camp session (due to behavior, illness/injury, or at the end of the day).
- For safety reasons, additions to the camper Release Form must be made by a signed, written note. Changes by phone will not be accepted
- ***For your child's safety, presentation of a valid driver's license will be required at pickup.***

I authorize the following adults to pick-up my camper at the end of the camp day (1:00 PM), or as needed should he/she need to leave camp due to illness/injury or behavioral concerns. The individuals listed have been informed by me that they may be contacted and that they need to produce a valid driver's license as proof of identity.

# Zoo Camp Sign-In/Sign-Out Policy Form

## Sign-In Procedure

- ◆ Each morning of camp, the camper 's Parent/Guardian must check the camper in with their counselor. If the camper has medication that must be accessible to them during the camp session, the medication must be shown to the camp counselor at check-in. Failure to furnish required medications may exclude the camper from attending camp that day.
  - All campers **MUST** have a completed Health Assessment Packet on file with the camp

## Sign-Out Procedure

- ◆ At sign-out, medications will be sent home with the camper.
- ◆ At sign-out, staff will compare the name of the person picking up the camper against the names of authorized persons listed on the release form.
  - Campers will only be released to authorized adults at least 18 years old who have a valid driver's license as proof of their identity.
  - Under no circumstance will a camper be released to an individual not listed on the release form.
